I/We, the parents or guardians of the above named participant, hereby give my/our approval to participate in any and all PVAA activities. I/We assume all risks and hazards incidental to such participation including but not limited to transportation to and from the activities. I/We hereby waive, absolve, indemnify and agree to hold harmless PVPV Athletic Association, its individual sports, the organizers, sponsors, supervisors, coaches participants and persons transporting my/our child for any claim arising out of an injury to my/our child whether the result of negligence or for any other cause, except to the extent and amount covered by accident or liability insurance.

Every parent is being asked to read and agree to a "Code of Conduct", which informs the parents of the PVAA's expectations regarding behavior and protocols of the Ponte Vedra Palm Valley Athletic Association. No child will be permitted to play in a PVAA sport unless this form is signed and turned in with all other registration materials.

- I will encourage good sportsmanship by being a good positive role model.
- I will try my best to make athletics a positive experience for everyone involved, i.e., participants, coaches, officials, and spectators.
- I will insist that my players will treat other players, coaches, officials and fans with respect.
- I will adhere to the bylaws or policies of the PVAA and its associated sports leagues requiring a parent or guardian of a youth to acknowledge the nature and risk of concussion, head injury, and heat-related illness which will include the risk of continuing to play after a concussion or heat-related injury. I acknowledge that if my player is suspected of receiving a concussion, head injury, or heat-related illness in a practice or competition, they will be immediately removed from the activity. That athlete may not return to practice or competition until the parent submits a written medical clearance to return stating the youth no longer exhibits signs, symptoms, or behaviors associated with a concussion, head injury, or heat-related illness.
- If I have a concern, I will talk to the coach at the appropriate time and place, i.e. never before, during or immediately after a contest. If the coach does not respond to my concern to my satisfaction, then I have the right to address my concerns to the sport's Board of Directors.
- At any PVAA sporting event or venue, any adult who:
 1. Verbally abuses; 2) attempts to intimidate; 3) is flagrantly rude; 4) cannot control their language or actions; 5) under the influence of drugs or alcohol will be asked to leave the event.
- Any adult that commits a second similar offense will be banned from any PVAA sponsored or affiliated events for a minimum of one year.
- Any adult who physically assaults an official, coach or volunteer will be banned from all PVAA sporting events for one year from the date of the offense. After one year, the parent may apply for re-instatement. If the adult commits a second offense, he or she will be permanently banned from such events.
